## *Class of 2010 Inductees Announced*

The Board of Directors of the Chautauqua Sports Hall of Fame has announced the members of the Class of 2010 who will be inducted at the CSHoF annual banquet to be held February 15, 2010 at the Lakewood Rod and Gun Club.

**ART ASQUITH** – An inductee of the Western New York Baseball Hall of Fame in recognition of his outstanding amateur career, the Cassadaga resident has coached multiple sports for over 50 years at Cassadaga Valley Central School.

**RAY CALDWELL** – A one-time resident of the Frewsburg area and inductee of the defunct Jamestown Sports Hall of Fame, the noted spitballer pitched for New York, Boston and Cleveland from 1910-1921.

**DAVE CRISCIONE** – Dunkirk's outstanding baseball player and SUNY Fredonia coach who made it to the major leagues with the Baltimore Orioles.

**PATRICK DAMORE** – Named the first commissioner of the State University of New York Athletic Conference, the Fredonia resident was an outstanding coach and Athletic Director at SUNY Fredonia for 30 years.

**TARA VANDERVEER** – The head coach of the Stanford University women’s basketball team and summer resident of Chautauqua Institution for nearly 40 years has won over 700 NCAA games, has led The Cardinal to two national championships and was the head coach for the 1996 gold medal USA Olympic team.
